NOTIFICATION

The Department of Health & Family Welfare Services, Puducherry in the advertisement No.A.12020/1/2013/E4/DHFWS dated 17.05.2013 have notified 15 vacancies for recruitment of the eligible candidates to the post of Health Assistant (Group 'C') carrying the Pay Band 1 of Rs.5200-20200 plus Grade Pay of Rs.2400 fixing the last date for receipt of filled in application on 21.06.2013.

2. In the Recruitment Committee meeting held on 03.10.2013, the following candidates have been provisionally selected for the post of Health Assistant, in the order of merit in their respective categories based on the 50% of marks obtained in SSLC or its equivalent and 50% of marks in Diploma in Multipurpose Health Worker (Male) or Diploma in Sanitation or Diploma in Health Inspector course / Health Assistant / Diploma in Public Health and Sanitation. A deduction of 5% of marks for every additional attempt in the requisite educational and technical qualification(s) shall be made. In addition to the above, 1.5 marks per every completed year of seniority from the date of registration of requisite educational or technical qualification(s), wherever applicable, in the Employment Exchange to the last date of receipt of duly filed in application will be added, subject to a maximum of 15 marks. Thus the qualifying marks have been calculated to the maximum total marks of 115 (50+50+15).

Offer of appointment shall be issued subject to availability of vacancies in the Health Institutions in the respective regions of the Union Territory of Puducherry and fulfilling other conditions and requirements as per rules and regulations in force and after verifying the original certificates in support of their Educational, Technical qualifications, Nativity, Caste certificates and Employment Registration card etc.
